Amendments to published monthly sports wagering reports – FY2026

08/26/2025 – An incorrect application of tax credits caused the report for July 2025 showed an incorrect amount of tax for Grand Falls Casino & Resort and Riverside Casino and Golf Resort. The previously shown amounts were \$14,742.08 and \$984.55. The July 2025 report was updated to show the correct amounts.

03/24/2026 - The FY2026 Sports Wagering Revenue for Grand Falls Casino & Resort posted for the end of February 2026 was incorrect. The previously shown amount of \$2,095,080.12 for Sports Wagering Net Receipts was incorrect, the correct amount is \$2,169,696.56, and inadvertently did not include the online numbers from December of 2025. This also affected the sports wagering totals posted on the FY report. As of this date FY2026 report has been updated and shows the correct amounts.
