APPROVED WAGERS
Pursuant to rule 13.3

SECTION I: *Background*

The following table represents a full and complete list of approved wager offerings pursuant to Iowa Administrative Rule 13.3. Any wager offering not explicitly stated below for which a sports wagering facility operator or advance deposit sports wagering operator would like to offer, must be submitted by application to the Commission for investigation and approval.

Unless explicitly stated below, individual athlete and/or “Prop” wagers and bets are NOT pre-approved and must therefore be submitted to the Commission for investigation and approval. Once a “prop” wager has been submitted and approved for one sport/league or operator, then said wager will become available to all operators under the conditions approved and subject to rule 13.3(2).

A separate wager request form must be completed for each type of wager, as well as for each individual sports league. Written approval for all wager types is required prior to the offering of the wager. Once a wager has been approved, it is available to all operators under the conditions approved and subject to rule 13.3(2); before offering a wager, each individual operator must also receive commission approval for its house rules regarding: the payout information, definition of an official contest, and source of information used to determine the outcome.

Note: "X" signifies this type of bet is offered within the league or sport in the corresponding row of the "X"

***Note:** Player Propositions include but are not limited to: Futures/Outrights (i.e., MLB Cy Young Award, NFL MVP, NCAA Football Heisman Trophy), Totals, and individual statistics-based wagers whose outcome will be determined by the individual athlete or player's result of performance over a defined period of time (i.e., Player Z scores more than 15 points in the first half of game 1). At this time, the approved Player Proposition types outside of Futures/Outrights, are Player statistics Over/Under Totals; H2H wagers; Golf: end of round leaders, Place Betting: top 5, 10, 20, 30, 40.

****Note:** PointsBet submitted a request for approval of its proprietary wagering type, "PointsBetting," which determines its outcome and payout based on how much a bettor "wins" or "loses" on said wager.

*****Note:** Player proposition wagers do NOT include placing a wager on the performance or nonperformance of any individual athlete participating in a single game or match of a collegiate sporting event in which a collegiate team from this state is a participant – see Iowa Code, Chapter 491: Racing and Gaming Commission. Player proposition wagers for individual athletes from state of Iowa colleges are strictly prohibited.

The approval of Totals or Over/Under wagers includes wagers which would be placed on Totals or Over/Under set for specific periods or “in-game*” wagering, including but not limited to: halftime, quarter, inning, and period totals.

Additionally, Head-to-Head (H2H) in these instances refers to bets placed on events in which there are a field of competitors, but the bettor selects one of two pre-determined competitors (pre-determined by the sportsbook) to best the other in the prescribed event. The overall winner of said event may hold no weight in determining the outcome of H2H bets.

Wagers are only allowed to be placed on the “premiere” leagues for respective sports and NOT subordinate developmental leagues. I.e., MLB wagers are permissible, MiLB wagers are NOT permissible; NBA wagers are permissible, NBA G-League wagers are NOT permissible; elite-level ATP events are permissible; ATP Challenger events are NOT permissible.

Section III: *In-Game Wagering**

*In-game wagering is pre-approved for bet-types which are explicitly stated as approved on the Offerings Table. I.e., an alternative spread wager during a timeout of a NFL game is pre-approved.

Sportsbooks are in charge of setting their own “in-game wager” limits.

For all other types of in-game wagers, please submit a wager request form to the Iowa Racing & Gaming Commission for investigation and approval.
